HEALTH PROFESSIONS EDUCATION FOUNDATION AWARDS \$1.5 MILLION IN GRANTS FOR PHYSICIANS TO IMPROVE ACCESS TO HEALTHCARE IN UNDERSERVED AREAS

SACRAMENTO – The Office of Statewide Health Planning and Development's (OSHPD) Health Professions Education Foundation (Foundation) awarded approximately \$1.5 million in loan repayment grants to 16 physicians under the Steven M. Thompson Physician Corps Loan Repayment Program (STLRP). The awards recognize the commitment of physicians who are willing to provide direct patient care in underserved areas of California.

"The Steven M. Thompson Physician Corps Loan Repayment Program is part of a successful strategy in encouraging a diverse and highly qualified pool of healthcare professionals to practice in underserved areas of California," said OSHPD Director Dr. David Carlisle.

The STLRP was created to increase accessibility to healthcare services in California, while encouraging healthcare professionals to consider long-term options for service in underserved areas. By providing a financial incentive to repay educational debt, the Health Profession Education Foundation hopes to retain these physicians in the communities where they serve during their contractual obligation.

Since its inception in 2003, the Foundation has encouraged physicians to practice in medically underserved areas of California by authorizing repayment of their educational loans. Physicians can receive up to \$105,000 in exchange for their service in a designated underserved area for a minimum of three years. Since 2003, the Foundation has awarded more than \$10 million to 118 individuals.

Established in 1987, under the Office of Statewide Health Planning and Development, the Foundation is California's only non-profit foundation statutorily created to increase access to health providers in medically underserved areas and encourage persons from underrepresented communities to become health professionals. Supported by grants, donations, licensing fees, and special funds, the Foundation provides scholarships, loan repayments and programs to students and graduates who agree to practice in California's medically underserved communities.
